



## Waiver of Liability Agreement Coronavirus/COVID-19

Due to the 2020 outbreak of the novel Coronavirus (“COVID-19”), Together4Children (“T4C”) has taken extra precautions to reduce the spread of COVID-19 by following these enhanced procedures: temperature checks, face coverings requirement, hand sanitation stations, disinfecting common surfaces, practicing social distancing, and providing individual classroom supplies. However, T4C cannot guarantee that you will not become exposed or infected with COVID-19.

I acknowledge that I do not currently have or have had, in the last 14 days, any of the following:

- a. Cough (unrelated to chronic condition)
- b. Shortness of breath or difficulty breathing (unrelated to chronic condition)
- c. Chills
- d. Repeated shaking with chills
- e. Muscle pain
- f. Headache
- g. Sore throat
- h. Loss of taste or smell
- i. Diarrhea
- j. Feeling feverish or temperature greater than or equal to 100.0 degrees Fahrenheit
- k. Known close contact with a person who is lab confirmed to have COVID-19
- l. Positive Covid-19 lab test

I further acknowledge that:

- a. I will not be allowed to attend the T4C professional development training if I do have any of the above symptoms.
- b. T4C cannot be held liable for any exposure to the COVID-19 virus caused by misinformation on this form provided by each participant.

By signing this waiver, I acknowledge there is inherent risk of exposure to Covid-19 that exists in any public place where people are present and voluntarily agree to **ASSUME ALL OF THE RISKS** that I may be exposed to or infected by COVID-19. I also acknowledge and accept sole responsibility for any injury to myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my attendance at T4C professional development trainings. I also acknowledge that the risk of becoming exposed to or infected by COVID-19 may result from the actions, omissions, or negligence of myself and/or others, including, but not limited to, T4C employees, directors, contractors, volunteers, and participants.

In consideration of the opportunity afforded to me to attend T4C professional development trainings and with acceptance of the all risks associated with such attendance, **I HEREBY RELEASE, COVENANT NOT TO SUE, DISCHARGE, AND HOLD HARMLESS** T4C, its employees, directors, volunteers, agents, representatives, and any other person involved either directly or indirectly, of and from all claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of T4C, its employees, directors, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any T4C training. It is further understood and agreed that this Coronavirus/COVID-19 Waiver of Liability Agreement is to be binding on my heirs and assigns and I sign it of my own free will.
